### **March General Meeting - Presentation by Point Lonsdale Surf Life Saving Club**

Mr Michael Doery, President, Point Lonsdale Surf Life Saving Club attended the March general meeting.

Mr Doery gave an overview of the club's proud history of service to the Point Lonsdale community and how the club's need for a modern, purpose built facility will benefit the community now and in the future. Mr Doery briefly discussed the site selection process, dispelling myths surrounding the current proposal. He acknowledged the cooperation of Borough of Queenscliffe Council in continuing to work with the club to identify a suitable site. At the conclusion of the presentation meeting members unanimously endorsed Council's intent to sell land to the Point Lonsdale Surf Life Saving Club for a nominal amount.
